District Office: Daniel Reed presented a summary Power Point report Measure G SRID, for April 24, 2024. District SRID spending summary included the original Measure G budget of \$180,000,000. Interest and other revenues are \$26,318.774. Total SRID funds are \$206,318,774. Total funds spent to date are \$200,719,494. Total funds unspent to date are \$5,332,836. A bar graph showed SRID Expenditures by College including District Office of \$200,719,494, Porterville College of \$30,746,857, Cerro Coso Community College of \$40,450,444, and Bakersfield College of \$100,736,987, totaling \$20,719,494. In addition, Daniel reported on the District Measure J spending summary for April 24, 2024. Spending summary included the original Measure J budget of
