### Answers to bidder questions:

- Q1.** In response to Addendum 3, Q.8: Pseudo SSNs is not a familiar process. How long does this take for EDD approval? Will this be required for community members who participate in training and workforce development activities too? What assurances do we have that this is a safe process and participants' data will not be shared?

**Answer:**

**How long does this take for EDD approval?**

The EDD does not have an established timeframe for approval since, approval is on a case-by-case basis. However, participant data needs to be inputted within a 30-day timeframe from when activities occur, so we do not expect determination to take longer than that timeframe.

**Will this be required for community members who participate in training and workforce development activities too?**



Social security numbers would be required for participation in training and workforce development activities, if it is also determined that the participants need to be enrolled in CalJOBS.

**What assurance do we have that this is a safe process and participants' data will not be shared?**

The Employment Development Department (EDD) is committed to protecting the privacy rights of individuals. It is our policy to limit the collection of personal information and protect the personal information it collects and maintains.

Regarding the sharing of data outside of government entities, CalJOBS maintains strict controls to prevent unauthorized access to participant information. Any sharing of participant information with employers or other entities would be subject to explicit consent or approval, ensuring compliance with privacy regulations and protecting participants' sensitive information.

- Q2.** Is there a way to raise concern over a participant who helped write this, make decisions, and is also applying for this? This really seems concerning. Is there a way to request how the governing board will make sure their decision is not influenced unfairly by having a fellow member applying for this project?

**Answer:** Any individual who contributed to the development of the RFP or participated in governance decisions and is also applying for funding is strictly recused from all aspects of review, scoring, and decision-making. This conflict-of-interest policy is mandated by the state and enforced without exception. The Governing Body will not accept input or involvement from any applicant at any stage of the evaluation process.

- Q3.** Are there any certain eligibility requirements regarding what organizations can apply?

**Answer:** Eligible applicants must meet Legal Capacity: Organizations must be legally able to contract within the State of California. Alignment with Program Priorities: Applicants must show alignment with the core priorities of California Jobs First, including equity, community engagement, and inclusive economic development.

- Q4.** Please clarify the type of information needed for the Climate Impact question related to Greenhouse Gas Emission Reduction. Should responses describe the reduction, or should they reference tools or resources used to determine the reduction?

**Answer:** Applicants should provide both a description of the anticipated reduction in emissions and reference any tools, methodologies, or resources used to estimate or support that reduction. This could include data models, calculators, or alignment with state-recognized frameworks or climate action plans. The goal is to demonstrate an informed and measurable approach consistent with the objectives of the California Jobs First Catalyst Phase.



**Q5.** Can Lost Hills community receive funding through this grant opportunity? Also, what region are they in?

**Answer:** The Lost Hills community is eligible to receive funding under the Catalyst Phase of California Jobs First, administered through the Kern Coalition. Lost Hills is located in West Kern region.
